Terms & Conditions

1 Description of Services

1.1

Akhanani Training Solutions (Pty) Ltd (hereinafter "Akhanani") provides access to a web-based learning platform service with the ability to:

1.1.1

Search a website for educational content, categorised into different levels [high school, university, business and other], subjects [within a level] and lessons [within a subject].

1.1.2

Purchase unlimited access to selected educational content in the form of lessons; and

1.1.3

Create a unique user profile, wherein all purchased educational content related to a lesson, will be accessible.

1.2

The educational content offered as part of each lesson purchased via the web-based learning platform service includes unlimited streaming of a pre-recorded video, a question paper [in PDF] and answers to the question paper [in PDF].

1.3

The web-based learning platform service facilitates purchases of lessons through an online shopping cart facility built into the platform. The service is therefore not subscription based.

1.4

Hereinafter, this web-based learning platform service and its capabilities as described in 1.1-1.3 are collectively referred to as "the Services".

1.5

The Services may be updated, enhanced, have new features added or existing features removed without notice. Akhanani will, however, endeavour to inform you, the user, of any changes to features and/or Services as envisaged.

1.6

Hereinafter, a "Lesson" or "Lessons" relates to educational content comprising the ability to stream a pre-recorded video, a question paper and answers to the question paper.

Akhanani does not guarantee the availability of the Services offered on this website or the accuracy of the information on this website. We make no representations or warranties, whether express or implied, and assume no liability or responsibility for the proper performance of this website and/or the Services and/or the information contained on this website, and the Services are thus used at your own risk. In particular, we make no warranty that the Services will meet your requirements, be uninterrupted, timely, and secure or error-free.

6.1

8.3

A unique student number is automatically generated by the platform, based on the Date of Birth input. A student number along with your password are necessary for future logins to the platform.

8.4

Registration for the Services is to be done by you on an individual user basis.

9 Fees, Payment, Refunds and Termination

9.1

Fees are charged per Lesson ordered.

9.2

The Services do not involve the need to pay a periodic subscription fee, as you will retain access to your Profile whereby a purchased Lesson can be viewed an unlimited number of times.

9.3

Payment is facilitated through a secure, web-based, payment platform, entitled 'Netcash' [refer <u>https://netcash.co.za/</u> for more information], which is built into Akhanani's web-based learning platform. Your email address and telephonic contact number are required as inputs on the Netcash payment platform screen. Netcash allows for the following methods of payment:

9.3.1

Credit & Debit Card, Instant EFT with Ozow, Bank EFT, QR Code Payments, VISA Checkout and Cash Payments through designated retailers.

9.3.2

A successfully approved payment will thereafter allow you to access the purchased Lesson(s) via your Profile.

9.4

Refunds on purchased Lessons are not permitted.

9.4.1

It is your responsibility as the user, to confirm your selected Lesson(s) before finalising payment, as Akhanani will not be held liable for refunds of any kind.

9.4.2
